Motion by Summy/Lee to approve the agenda; Greenway,Hansen,Huen,Lee,Summy all in favor; Motion carried 5-0.

Motion by Summy/Hansen to approve the consent agenda; Greenway,Hansen,Huen,Summy in favor; Lee opposed; Councilwoman Lee does not approve of the timecard used by public works; Motion carried 4-1.

Motion by Summy/Huen to approve Resolution 2016-02; A Resolution setting dates of a consultation and a public hearing on a proposed amendment no. 5 to the De Soto Urban Renewal Plan in the City of De Soto, State of Iowa. Greenway,Hansen,Huen,Lee,Summy all in favor; Motion carried 5-0.

Motion by Lee/Huen to approve the annual Urban Renewal Report for fiscal year 2014/2015 for the Iowa Department of Management. Greenway,Hansen,Huen,Lee,Summy all in favor; Motion carried 5-0.

Motion by Greenway/Lee to approve the estimated cost up to \$35,000 for a new vehicle for the De Soto Police Department; Greenway,Huen,Lee,Summy all in favor; Hansen opposed. Motion carried 4-1.

Motion by Greenway/Summy to advertise and accept closed bids for the 2005 Ford Crown Victoria vehicle, with a minimum bid of \$2,000.00; Greenway,Hansen,Huen,Lee,Summy all in favor; Motion carried 5-0.

Item #5 was tabled; No action taken.

Motion by Greenway/Summy to have City Attorney Dalen draft a new ordinance increasing the no parking fine on Adair/Ash Street to \$100.00; Greenway,Hansen,Huen,Lee,Summy all in favor; Motion carried 5-0.

Motion by Huen/Hansen to set Saturday, October 31st from 6:00pm to 8:00pm for Halloween Beggars Night; Greenway,Hansen,Huen,Lee,Summy all in favor; Motion carried 5-0.

Having no other business Mayor Hasty asked for a motion to adjourn. Motion by Huen/Hansen to adjourn @8:15pm; Greenway,Hansen,Huen,Lee,Summy all in favor; Motion carried 5-0.
