Motion by Summy/Greenway to approve the site plan for Tractor Supply, located in Ashland Crossroads Plat 2, Lot 9, De Soto, Iowa. Greenway, Sanders, Summy, Wilson, Wright all in favor; Motion carried 5-0.

Motion by Summy/Sanders to approve the site plan for Victory Motor Shop located on Lots 32,33,34 Golden Circle Air Plat 2, De Soto, Iowa. Greenway, Sanders, Summy, Wilson, Wright all in favor; Motion carried 5-0.

Motion by Summy/Wilson to approve moving forward with the sale of city property located @216 Madison Street by having the property surveyed and by having an abstract created; approximate cost of \$2,650.00. Sanders,Summy,Wilson,Wright in favor; Greenway opposed; Motion carried 4-1.

No action taken on moving forward with a development agreement between the City of De Soto and Rick Madden Realty for building 8 houses on land between Cade and Warren Streets in De Soto.
