November 15, 2021 Meeting Minutes

The De Soto Board of Adjustment met at 7:44p.m.; Board Members, Mark, O'Leary, Mitch Crozier, Steve Jones, Don Pierce and Mat Sanders present; City Clerk Thomas and City Engineer Jordan Kappos present.

Motion by Sanders/Jones to approve the 09/14/21 board minutes as written; RC: all ayes, Motion carried 5-0.

Christy Eichorn representing Parallel Infrastructure and AT & T are proposing to construct a 220-foot self-support telecommunications tower located on Galynne and Bill Chapman property north of 34330 Noble Court, Adel, IA. Jordan Kappos, City Engineer, said in Chapter 165 Zoning Regulations there are 4 tests that the Board of Adjustment should look at prior to granting a variance. If the applicant has demonstrated that they meet those requirements, then the variance may be granted. James Nervig with Brick Gentry Law firm, representing SBA Communications Corporation owns a cell tower 0.12 miles from the proposed new location for the cell tower. SBA says they can accommodate additional equipment for AT&T on the existing cell tower and does not feel the City of De Soto should grant any variances. Discussion took place; Motion by Jones/Sanders to table the approval of the requested variances until legal advice is given from the City Attorney; all ayes, Motion carried 5-0.

With no further business to come before the board at 8:15pm; Crozier moved seconded by Sanders to adjourn the meeting, RC: all ayes, motion carried.
