

## **CITY OF DESOTO – REGULAR COUNCIL MEETING MINUTES**

June 20, 2023 – Mayor Mitch Crozier called the meeting to order at 7:02pm.

Answering roll call was: Erin Blume, Ted Hansen, Mark O’Leary, Josh Minton and Dustin Padget.

Staff present included City Clerk Marcia Thomas, Public Works Director Dan Van Langen, Police Chief John Sparling, Fire Chief Tim Murray and City Attorney DuWayne Dalen.

Motion by Minton/Padget to approve the agenda; Blume, Hansen, O’Leary, Minton, Padget in favor; Motion carried 5-0.

Motion by O’Leary/Padget to approve the consent agenda; Blume, Hansen, O’Leary, Minton, Padget in favor; Motion carried 5-0.

Motion by Hansen/Minton to approve Far West Mexican Food Truck set up in De Soto Monday thru Saturday contingent upon proof of insurance; they will be setting up on the west side of Hwy 169 across from Ambros; Blume, Hansen, O’Leary, Minton, Padget in favor; Motion carried 5-0.

Motion by Minton/O’Leary to approve the second reading of Ordinance No. 362; An Ordinance amending the Code of Ordinances of the City of De Soto, Iowa, 2009, by rezoning LeMar Koethe property located in the SE ¼ of section 19 and NE ¼ of section 30, Township 78 North, Range 27 West of the 5<sup>th</sup> PM from A-1 Agriculture to M-1 Light Industrial District; Mayor Crozier asked for a roll call vote; Blume, Hansen, O’Leary, Minton, Padget in favor; Motion carried 5-0.

Motion by O’Leary/Padget to approve the second reading of Ordinance No. 363; An Ordinance amending the Code of Ordinances of the City of De Soto, Iowa, 2009 by amending section 106.08(1) Collection Fee for disposal of solid waste; Mayor Crozier asked for a roll call vote; Blume, Hansen, O’Leary, Minton, Padget in favor; Motion carried 5-0.

Motion by Padget/O’Leary to suspend the rules and proceed to the 3<sup>rd</sup> and final reading of Ordinance No. 363; An Ordinance amending the Code of Ordinances of the City of De Soto, Iowa, 2009 by amending section 106.08(1) Collection Fee for disposal of solid waste; Mayor Crozier asked for a roll call vote; Blume, Hansen, O’Leary, Minton, Padget in favor; Motion carried 5-0.

Motion by Padget/O’Leary to adopt Ordinance No. 363; An Ordinance amending the Code of Ordinances of the City of De Soto, Iowa, 2009 by amending section 106.08(1) Collection Fee for disposal of solid waste; Mayor Crozier asked for a roll call vote; Blume, Hansen, O’Leary, Minton, Padget in favor; Motion carried 5-0.

Motion by Minton/Hansen to approve Resolution 2023-16; A Resolution approving the new Urban Chicken and Fowl Policy for the City of De Soto; this resolution allows ducks; Blume, Hansen, O’Leary, Minton, Padget in favor; Motion carried 5-0.

Motion by Padget/O’Leary to approve Resolution 2023-17; A Resolution approving permanent transfer of monies for fiscal year end 2022/2023; Blume, Hansen, O’Leary, Minton, Padget in favor; Motion carried 5-0.

Motion by Minton/O’Leary to approve MainStay Systems of Iowa LLC standard on-site annual maintenance contract; Blume, Hansen, O’Leary, Minton, Padget in favor; Motion carried 5-0.

Motion by Padget/O’Leary to approve Public Works purchase 2022 Big Horn 450 VXL-T- UTV from Moss Bros Inc; invoice price \$8,900.00; Blume, Hansen, O’Leary, Minton, Padget in favor; Motion carried 5-0.

Motion by O’Leary/Hansen to approve RD McKinney bid of \$17,525.00 to repair storm sewer on Cade Ct and replace storm sewer on Elm Street; Blume, Hansen, O’Leary, Minton, Padget in favor; Motion carried 5-0.

Motion by Minton/O’Leary to approve Xtreme Tree bid of \$1,565.00 to remove 3 Ash Trees on Elm Street and 2 Mulberry Trees between Casey’s and KwikStar; Blume, Hansen, O’Leary, Minton, Padget in favor; Motion carried 5-0.

Motion by O’Leary/Padget to approve Dykstra Concrete LLC emergency street repair on Chestnut Street; estimate is \$20,735.00 but could increase once street is removed and more damage is found; Blume, Hansen, O’Leary, Minton, Padget in favor; Motion carried 5-0.

Councilman Mark O'Leary turned in a letter of resignation to Mayor Crozier and City Council effective August 1, 2023; Mark and his wife have sold their home in De Soto and are moving out of the city limits.

Having no other business Mayor Crozier asked for a motion to adjourn; Motion by O'Leary/Minton to adjourn @8:00p.m.; Blume, Hansen, O'Leary, Minton, Padget in favor; Motion carried 5-0.
