Mayor Crozier opened the Public Hearing for Budget Amendment for fiscal year beginning July 1, 2023 and ending June 30, 2024 @6.33p.m. Clerk Thomas said she had not received any phone calls or written correspondence regarding the public hearing. Motion by Fox/Padget to approve Resolution 2024-19; A Resolution setting the compensation for employees for the fiscal year 2024-2025; Discussion took place; Councilman Davis said the social security cost of living for 2024 was 3.2%; Davis also said he contacted several cities with a range from 3% to 6% for proposed wage increases; Clerk Thomas said the 4% wage increase was discussed during budget workshops in January; Councilman Davis asked that a finance committee be formed to discuss wage increases for the next budget season; Chief of Police Sparling annual salary will be \$71,060; Police Officer Wagenknedt hourly rate \$26.50; City Clerk Thomas \$34.05; Library Director Glenn \$24.09; Public Works Director Van Langen \$33.71; Public Works employee Eckstein \$29.37; Utility Billing Clerk Bach \$17.68; Police/Fire Administrative Assistant Olson \$17.94; Library employee Henderson \$17.64; Mayor Crozier asked for a roll call vote; Davis, Fox, Minton, Padget in favor; Motion carried 4-0.
