Motion by Daly/Stratton to recommend to the De Soto City Council the approval of the site plan submitted by MAK CCEC, LLC; Lots 11 & 12 in Ashland Crossroads Plat 2, De Soto, Iowa; the building will be for a Bobcat compact equipment sales and service dealership; Discussion took place; All in favor; Motion carried 5-0.

Motion by Stratton/Thayer to recommend to the De Soto City Council the approval to rezone city owned property; parcels 1530135025 & 1530135026; Block 10; Lots 3,4,5,6,7; City requesting a zoning designation of R-1 Single-Family Residential District subject to the property being surveyed; Discussion took place; all in favor; Motion carried 5-0.

Motion by Thayer/Hammel to not recommend to the De Soto City Council the approval to rezone property owned by Bill & Galynne Chapman; approximately 62 acres; parcels 14242008, 1424100004, 1424200010; amended plat of Chapman Estates; The Chapmans are requesting a zoning designation of M-2 Heavy Industrial District; Discussion took place; neighbors owning property near the Chapman property spoke and were against the M-2 Heavy Industrial zoning designation; all in favor for not recommending to the City Council the M-2 Heavy Industrial designation for the Chapman property; all in favor; Motion carried 5-0.
