

CITY OF DESOTO – REGULAR COUNCIL MEETING MINUTES

January 21, 2025 – Mayor Crozier called the meeting to order at 6:00pm.

Answering roll call was: Wade Fox, Bobby Huntoon, Josh Minton, Dustin Padget; absent, Ted Davis.

Staff present included City Clerk Marcia Thomas, Police Chief Josh Sienkiewicz, Public Works Director Dan Van Langen, Fire Chief Adam Hilgenberg and City Attorney DuWayne Dalen.

Motion by Huntoon/Padget to approve the agenda; Fox, Huntoon, Minton, Padget in favor; Motion carried 4-0.

Motion by Padget/Fox to approve the consent agenda; Fox, Huntoon, Minton, Padget in favor; Motion carried 4-0.

Mayor Crozier assigned Councilman Padget as Mayor Pro-Tem and Street Liaison, Councilman Josh Minton as Water/Sewer Liaison, Councilman Ted Davis as Park/Cemetery Liaison, Councilman Bobby Huntoon as Fire Department Liaison and Councilman Wade Fox as Employee Liaison.

Motion by Fox/Huntoon to approve Resolution 2025-13; A Resolution designating E Bank Savings Bank as the City Depository of Funds with the maximum amount being \$3,500,000.00; Fox, Huntoon, Minton, Padget in favor; Motion carried 4-0.

Motion by Huntoon/Padget to approve Resolution 2025-14; A Resolution designating The Dallas County Newspaper of publication for the City of De Soto; Fox, Huntoon, Minton, Padget in favor; Motion carried 4-0.

Motion by Fox/Huntoon to approve Resolution 2025-15; A Resolution approving the City of De Soto Investment Policy; Fox, Huntoon, Minton, Padgett in favor; Motion carried 4-0.

Motion by Fox/Minton to appoint Mayor Crozier as the Mid-Iowa Planning Alliance for Community Development representing the City of De Soto; Fox, Huntoon, Minton, Padgett in favor; Motion carried 4-0.

Motion by Minton/Huntoon to approve estimate of \$1,270.00 from Danko Emergency Equipment for the Fire Department purchase for gate valve for truck #420; Fox, Huntoon, Minton, Padgett in favor; Motion carried 4-0.

Having no other business Mayor Crozier asked for a motion to adjourn; Motion by Minton/Huntoon to adjourn @7:20p.m.; Fox, Huntoon, Minton, Padgett in favor; Motion carried 4-0.
