Motion by Padget/Minton to approve the agenda; Fox, Huntoon, Minton, Padget in favor; Motion carried 4-0.

Motion by Padget/Huntoon to approve the consent agenda; Fox, Huntoon, Minton, Padget in favor; Motion carried 4-0.

Motion by Minton/Huntoon to approve Veenstra & Kimm, Inc engineering agreement for Professional Services for the new fire station; Huntoon, Minton and Padget in favor; Fox opposed; Motion carried 3-1.

Motion by Fox/Minton to approve the estimate of \$4,460.50 from Land Pride for a core aerator attachment for the Kubota Tractor; Fox, Huntoon, Minton, Padget in favor; Motion carried 4-0.

Motion by Minton/Padget to approve the bid of \$319,431.00 from Grimes Asphalt and Paving Corporation for Ellefson Drive rehabilitation (Crack and Seal existing pavement); Fox, Huntoon, Minton, Padget in favor; Motion carried 4-0.

Discussion took place regarding the clean up of 2 Ellefson Drive; Motion by Fox/Huntoon to have City Attorney draft a letter to MCA Metal Fabrication giving him until April 6, 2025 to clean up his property; Fox, Huntoon, Minton, Padget in favor; Motion carried 4-0.

Motion by Fox/Huntoon to approve estimate up to \$4,000 from Task Force Tips for 2 intake valves for truck # 421; Fox, Huntoon, Minton, Padget in favor; Motion carried 4-0.

Motion by Fox/Minton to set Public Hearing for the sale of real estate owned by the City of De Soto; parcels 1530135025 & 1530135026 for April 15, 2025 @ 6:00p.m.; City Council chambers, 405 Walnut Street, De Soto, IA; Fox, Huntoon, Minton, Padget in favor; Motion carried 4-0.
