Motion by Minton/Davis to approve Resolution 2026-04; A Resolution approving the Plat of Survey for parcels 25-89 and 25-90 located at 103 Elm Street, De Soto, Iowa; Roll Call vote; Davis, Fox, Huntoon, Minton, Padget in favor; Motion carried 5-0.

Motion by Minton/Huntoon to approve Resolution 2026-05; A Resolution waiving the right to review of the Plat of Survey for parcel 25-92 located on Maple Ridge Drive, Dallas County, Iowa; Roll Call vote; Davis, Fox, Huntoon, Minton, Padget in favor; Motion carried 5-0.

Motion by Padget/Davis to approve Police Chief Sienkiewicz move forward with the purchase of a 2026 Tahoe from Karl Chevrolet, (Chief Sienkiewicz received a \$30,000 grant from Prairie Meadows towards the vehicle purchase); Davis, Fox, Huntoon, Minton, Padget in favor; Motion carried 5-0.

Motion by Padget/Davis to set Beggar’s Night Friday, October 31st from 6:00p.m. to 8:00p.m.; Davis, Fox, Huntoon, Minton, Padget in favor; Motion carried 5-0.
